

- One of the many supplier checks carried out by Xbert is that it will recognise (via ASIC) if a supplier is/is not registered for GST and can warn against incorrect claims for GST.
- Similarly, Xbert checks payroll data and can raise warnings such as when an employee under the age of 21 has a birthday, to ensure that they are paid the correct award rates.

26 May

Quarter 3 (January–March) BAS – final date for lodgment and payment




BOB
